As the owner of the above mare, I warrant the she is in sound health for breeding, and has a negative cervical culture, this fact to be certified by a qualified veterinarian before the mare is bred. This applies to all mares using live, shipped fresh or frozen semen.

I agree to hold neither the owner of the stallion, nor the farm, nor any of the handlers listed below responsible for any accidents or disease.

This contract shall not be assigned or transferred and in the event the mare is sold, the fee, if unpaid, shall immediately become due and payable.

It is further agreed that should the stallion die, be sold by the owner, or become unfit for breeding before servicing the mare, or if the mare, as named in this contract, dies or becomes unfit for breeding, then this contract shall be null and void.

I agree to have the mare examined for pregnancy by a licensed veterinarian within 45 days of service and to notify _____ in writing of the results of the exam. Should the veterinarian find the mare to be barren, this contract guarantees return privilege for the same mare the year of service. Should the mare fail to produce a foal that will stand and suck, return privilege is guaranteed for the year following initial service. For return service, the stallion service fee shall be waived; however, the handling

and collection fee plus the refundable container deposit must be paid prior to subsequent semen shipments.

The Stallion service fee of \$ _____ shall be payable in full prior to stallion service or before transported semen is shipped. Should more than two semen shipments be necessary for live fresh semen a \$ _____ handling and collection fee will be required for each additional semen shipment. The mare owner is responsible for the cost of shipping semen and returning the container immediately to the stallion owner. A \$ _____ refundable container deposit is also required prior to shipment of transported frozen semen. This container deposit will be refunded upon return of the semen shipping container provided it is received within 7 days following breeding. A \$ _____ daily board fee is required for mares sent for breeding by natural cover.

For service by Transported Semen _____ assumes responsibility to deliver live semen in viable condition at the time of delivery to the mare owners farm. For service by Frozen Semen * _____ assumes responsibility to deliver Frozen Semen in viable condition at the time of delivery to the mare owners farm. The semen in either case must be administered by a licensed veterinarian or technician on the day of delivery or the mare owner shall not be considered to have fulfilled the contractual obligations herein and all guarantees and privileges in this contract shall not apply. Frozen Semen is not held under same day insemination obligation.
